## **COURSE DESCRIPTION:**

This course covers the specific culture techniques used in the production of a variety of aquatic species. Emphasis is placed on species of economic importance in North Carolina, especially channel catfish, hybrid striped bass, rainbow trout, crawfish, clams and oysters. Upon completion, students should be able to describe the various culture methods and prepare a production plan for each of the species covered.

#### STUDENT LEARNING OUTCOMES:

Upon successful completion of this course, the student will be able to:

- 1. Discuss culture techniques used in North Carolina and elsewhere for the production of channel catfish, largemouth bass, and other warm water finfish species.
- 2. Describe culture techniques for the production of rainbow trout in coldwater raceways and ponds of the North Carolina mountains, and culture of cool water species such as yellow perch
- Discuss bottom and off-bottom culture of Atlantic and Pacific species of oysters, and the outlook for the future of oyster culture in the coastal waters of North Carolina.
- 4. Describe hard clam culture techniques, including the production of early stages in upweller and raceway systems as well as bottom culture to market size. Constraints to clam culture and economic viability of clam culture in coastal North Carolina is a central theme.
- 5. Discuss culture methods for crawfish in current use in the southeastern U.S., including pond production of hardshell crawfish, intensive soft-shell crawfish production, crawfish tailmeat processing, and economics of crawfish production.
- 6. Describe culture techniques for the penaeid (marine) shrimps as well as freshwater shrimp in various parts of the world.
- 7. Discuss the construction and management of water gardens.
