- 27. Demonstrate and select the correct perm procedure and product for client hair.
- 28. Describe the chemistry of perm waving and hair relaxers.
- 29. Demonstrate selecting the correct relaxer for client hair.
- 30. Demonstrate analyzing the condition of the hair.
- 31. Identify the care, styling and application of artificial hair.
