### **COURSE DESCRIPTION:**

This course provides advanced experience in a simulated salon setting. Emphasis is placed on efficient and competent delivery of all salon services in preparation for the licensing examination and employment. Upon completion, students should be able to demonstrate competence in program requirements and the areas covered on the Cosmetology Licensing Examination and meet entry-level employment requirements.

#### STUDENT LEARNING OUTCOMES:

Upon successful completion of this course, the student will be able to:

- 1. Demonstrate thermal curling, testing the iron, and sectioning the hair correctly.
- 2. Demonstrate establishing a base for a thermal curl.
- 3. Demonstrate distributing the hair evenly around the iron.
- 4. Demonstrate rolling the iron from the base to the ends of the hair while clicking.
- 5. Demonstrate protecting the scalp with the comb.
- 6. Demonstrate forming the curls so that they are smooth and hair is unmarked.
- 7. Demonstrate using the iron safely at all times.
- 8. Demonstrate hair shaping in 30 minutes.

- 9. Demonstrate using a neck strip or towel and applying a drape securely.
- 10. Demonstrate establishing a nape guide with a razor.
- 11. Demonstrate sectioning the hair in clean even partings, and follow established guidelines throughout the hair.
- 12. Demonstrate the correct procedure for chemical waving.
- 13. Demonstrate applying cotton and protective cream around facial hairline and nape.
- 14. Demonstrate applying lotion across the entire perm rod making sure all curls are completely saturated.
- 15. Demonstrate properly executing a test curl.
- 16. Demonstrate wrapping rods with correct tension on hair and placing the bands correctly.
- 17. Demonstrate wrapping hair by measuring the hair subsection with the length of the rod; making sure the hair is spread evenly across the end paper.
- 18. Demonstrate hair wrapped to form a full curl.
- 19. Demonstrate the correct application of hair lightening and hair coloring.
- 20. Demonstrate the proper application of a hair relaxer.
- 21. Demonstrate the correct procedure of blow dry styling
- 22. Demonstrate performing a ridge curl and "C" shaping.
- 23. Demonstrate different roller placements in hair designs, and show that the roller is securely clipped correctly.
- 24. Demonstrate the correct facial procedure.
- 25. Demonstrate the correct manicure procedure.
- 26. Demonstrate the correct way of applying artificial nails.

The Student Learning Outcomes listed in this syllabus are those required actions that a student who successfully completes the course must be able to perform. The educational experience, however, is a two-way, interactive process involving both the student and the instructor. The student must play an active role in the learning process in order to be successful.
