This course provides an opportunity to enhance acquisition of the fundamental elements of the Spanish language. Upon completion, students should be able to comprehend and respond with grammatical accuracy to spoken and written Spanish and demonstrate cultural awareness. #### **SYLLABUS INFORMATION:**

## **GRADING SYSTEM:**

Brunswick Community College employs a system of letter grades and corresponding quality points per grade to evaluate a student's performance in meeting the stated goals and objectives for each course. The grading system is published in the <u>BCC Catalog and Student Handbook</u>.

#### ATTENDANCE POLICY:
