COURSE DESCRIPTION:

This course provides a comparison of diverse roles, interests, opportunities, contributions, and experiences in social life. Topics include race, ethnicity, gender, sexual orientation, class, and religion. Upon completion, students should be able to analyze how cultural and ethnic differences evolve and how they affect personality development, values, and tolerance. This course has been approved to satisfy the Comprehensive Articulation Agreement general education core requirement in social/behavioral sciences.

STUDENT LEARNING OUTCOMES:

Upon successful completion of this course, the student will be able to:

- 1. Define culture, assimilation, acculturation, and cultural differences.
- 2. Identify the key characteristics of different types of diversity including race, ethnicity, gender, sexual orientation, class, and religion.
- 3. Identify the origins of stereotyping, prejudice, bias and discrimination and the ways to avoid them.
- 4. Describe ethnocentrism and its relationship to diversity.
- 5. Recognize the state, national, and world demographics pertaining to diversity.
- 6. Recognize the internal diversity of U.S. society and the significance of variations by race/ethnicity, gender, sexuality, class, age.
- 7. Identify the characteristics that separate culture from personality traits.
- 8. Evaluate the impact of social class, gender, race/ethnicity/immigrant status, age, religious status, and sexual orientation on people's chances in life, their practices, and attitudes.

SYLLABUS INFORMATION:

The Student Learning Outcomes listed in this syllabus are those required actions that a student who successfully completes the course must be able to perform. The educational experience, however, is a two-way, interactive process involving both the student and the instructor. The student must play an active role in the learning process in order to be successful. Instructors will provide an Instructor's Syllabus at the first class meeting explaining how they measure each of the Student Learning Outcomes. A student who is unable to accomplish the outcomes will not receive a passing grade in the course.

GRADING SYSTEM:

Brunswick Community College employs a system of letter grades and corresponding quality points per grade to evaluate a student's performance in meeting the stated goals and objectives for each course. The grading system is published in the <u>BCC Catalog and Student Handbook</u>.

ATTENDANCE POLICY:

Each student has individual responsibility for attending class regularly and for meeting course objectives. A student is expected to attend all class meetings in a course.
